\*\* The scope of this registration include renewal of the 8NPS Hammer Trunnion Assembly (originally accepted for registration under 2015-05387, with drawing CRN070215/CRN070215-BOM Rev A-05/A-05). The design code is changed from ASME Section VIII Div.1 to ASME B31.3, and the weld neck material is changed from SA-106B to SA-106C. The blind plate, o-ring, hammer union nut and weld neck was already registered under 0H04652.2. The new drawing # is CRN07611 Sht 3 Rev A-06.

As indicated on AB-41 Statutory Declaration or AB-351 Declaration of Conformity form and submitted documentation, the code of construction is ASME B31.3.
